It focuses on using this internationally accepted computer audit standard for the **audit assurance process** and ranges from using CobiT™ for generating a strategic IT audit plan, through scoping an individual audit to the final assurance testing.

Workshop Structure & Content

This intensive two-day workshop will focus on the use of CobiT™ in the audit assurance process. The sessions will be a mix of formal lectures and syndicate exercises.

It will show how CobiT™ can be used to:

- Prepare a strategic IT audit plan based on the 34 CobiT™ Process Areas
- Assess process maturity using CobiT™ capability maturity modelling
- Evaluate the comprehensiveness of IT risk identification
- Validate the accuracy of IT risk scoring
- Rationalise the requirement for an audit using the CobiT™ Framework descriptions
- Prepare a tactical audit plan based on the CobiT™ Audit Guidelines
- Scope the audit using CobiT™ Key Goal Indicators and Critical Success Factors
- Test & assess control effectiveness based on the CobiT™ Control Practices

The workshop leader will be John Mitchell, who is a past President of the Chapter and recipient of ISACA’s John Kuyers’ award for best conference speaker.
