

CGEIT Revision Workshop

17th – 18th May 2010



The London Chapter is pleased to offer its specially designed revision workshop for ISACA's CGEIT (Certified in the Governance of Enterprise IT) examination. This will be a two day non-residential course on 17 – 18 May 2010 at a central London location.

The workshop leader will be John Mitchell CISA CGEIT who is a past President of the London Chapter and a recipient of ISACA's prestigious John Kuyers' award for best conference contributor. John is a very experienced trainer who has delivered training courses and workshops all over the world.

The CGEIT Revision Workshop

This intensive workshop provides an excellent opportunity to clarify the thought processes when working under pressure. The format is primarily a review of the task and knowledge requirements for each CGEIT domain, including test questions with a discussion on the 'correct' answer to each question. Some time is also allocated for examining the structure of a CGEIT question and discussing a generic approach to help identify the appropriate answer. This not only hones the delegates' examination technique, but also provides for lively discussion.

It is emphasised that this is a revision course i.e. an opportunity to go over work already done prior to taking the exam; it is not a course of study. Delegates are expected to have previously studied and absorbed the subject matter described on the ISACA International web site.

The actual CGEIT examination is scheduled for Saturday 12 June 2010 so delegates will have three weeks to address any weaknesses identified during the workshop.

CPE Credits

The workshop is worth 15 hours continuous professional education credits for those who are CISA or CISM Certified.
